PAYMASTER SERVICE AGREEMENT
This Agreement dated this day of, 2024 outlines the paymaster services to b provided by Kim J. King Associates, LLC, (hereinafter referred to as KKA), t, (hereinafter referred to as the Client).
KKA shall exclusively use its Attorney Escrow IOLTA Account, to accept, retain and disburs transaction funds pursuant to client instructions. The Client agrees to pay KKA according to the Agreement all amounts due pursuant to the schedule contained as Exhibit "A". It is mutuall understood that this Agreement and Exhibits are binding and any amounts paid by the Client as the fee to KKA are irrevocable. KKA assumes responsibility for making all disbursements pursuant to the Client's written Disbursement Schedule. Client acknowledges that KKA's fee shall be deducted prior to KKA making any disbursements. In consideration for services rendered, KKA will charge the Client the sum as detailed in Exhibit "A".
In addition, the Client agrees to indemnify, defend, and hold KKA and individuals acting on behalf of KKA and/or in an individual capacity harmless from and against any and all liabilities, damages, costs expenses and/or other losses (including reasonable attorney's fees) whatsoever which KKA may suffer by and from the actions of the Client or its employees, agents, heirs or assigns hired on its behalf; of arbitration or litigation entered into on behalf of the Client.
Client agrees to complete all necessary documents requested by KKA to aid in the disbursement of funds. Additionally, the parties agree that KKA will disburse funds based upon Client's Writte Disbursement Schedule. Client certifies that all information submitted to KKA is accurate and true to

funds. Additionally, the parties agree that KKA will disburse funds based upon Client's Written Disbursement Schedule. Client certifies that all information submitted to KKA is accurate and true to the best of Client's knowledge. Further, KKA and the Client agree that their relationship is governed by the Attorney-Client privilege which protects the confidentiality of all communications between KKA and the Client.
